The following reports were given:

Harbor Safety Committee Chairman, Mario Munoz

Chairman Munoz called the meeting to order, led introductions, and made general announcements. Marine Industry Day went very well; thanks those who planned, participated, and attended. If anyone has feedback on the event, send to Christine Titus.

USCG Sector New Orleans

Several incoming members of Sector New Orleans introduced themselves, including Deputy Sector Commander CAPT Melanie Burnham. Hurricane Season: There is a new Sector New Orleans electronic form for Waterfront Facilities to submit in advance of a storm; the QR code on the new MSIB distributed in May links to the form. LCDR Tuo asked people to test the form in advance of a storm and send any feedback to her.

Bar Pilots – Captain Tim Lagarde

Pilottown Anchorages – There are no safe anchorages for larger ships due to silting; the Bar Pilots and several other groups urged attendees to advocate for funding for dredging. Southwest Pass ATONS – Six or seven ranges are down; the Bar Pilots and several other groups urged attendees to advocate for funding for replacement Floculation at Southwest Pass – When there is 10-13 feet draft, a gel-like substance forms that can be difficult to transit through. While the Corps has helped with surveys and using dredges to agitate it, it can create issues for ships and delays.

NOBRA Pilots – Captain Toby Wattigney

The Blessing of the Fleet is August 14-15, and starts in Baton Rouge and ends in New Orleans. Toby and several others thanked the Coast Guard for their help with the event and if anyone wants more information, to sponsor, or to be part of the planning meetings, reach out to Toby.

Big River Coalition – Sean Duffy

Sean announced that he submitted comments on a Corps of Engineers Lower Mississippi River study/plan and will send them to Mario and Christine for distribution to the HSC; he encouraged people to submit them on behalf of their organizations. He also provided updates on projected changes related to study results.

<u>CAMO – Ed Landgraf</u>

There is an abandoned pipeline at Convent (MM 158.1) that will be removed starting in mid-July (landside) and continuing into August (waterside)

Cybersecurity Subcommittee – Eric Acosta

Drones – If you are planning to fly a drone over a secure area, you still need to submit the "old" form for vetting and approval. TWICs – there was an in-depth discussion about how to use your TWIC to qualify for TSA Pre-Check, but your TWIC cannot be used as an ID during TSA screening at the airport.

Presentation

The Port of New Orleans gave a presentation about the plan for the Louisiana International Terminal (LIT) and new associated anchorages.
